

**2022 Town of Eau Galle  
3/14/22 Town Board Meeting Minutes**

Meeting was called to order at 6:35 p.m. by Donald Hartung on Monday, March 14, 2022, in the Eau Galle Civic Center, Eau Galle, WI.
