

**2022 Town of Eau Galle
4/11/22 Town Board Meeting Minutes**

Meeting was called to order at 6:00 p.m. by Chairman, Donald Hartung on Monday, April 11th, 2022, in the Eau Galle Civic Center, Eau Galle, WI.
