This agreement, made this 21st day of October 2015 by and between the Elmwood Area Fire Department, Inc, and the Town of Eau Galle, a municipal corporation of Dunn County, Wisconsin.

The Elmwood Area Fire Department, Inc hereby agrees that its personnel, when called, will furnish fire fighting service and equipment to the Town of Eau Galle for the following described area: Sections 6, R13W; Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24 and 28, R14W.

Non-contracted sections of the Town of Eau Galle will be covered by Mutual Aid, if and when a request for Mutual Aid is received from a member of any other fire department with which the ~~Elmwood Area Fire Department, Inc has a Mutual Aid Agreement. Fire calls will be answered~~ on a first call, first serve basis, with no charge to the Mutual Aid Department. The service charge is \$650.00 for the first hour and \$500.00 for each hour thereafter on 1/2 hour segments plus a water charge per 1000 gallons to be charged at the Village of Elmwood water rates. Minimum water charge will be \$5.00.

Special service charges:

- AFFF Class A Fire Fighting Foam per gallon \$25.00
- Fireman's Aid Wetting Agent \$15.00
- 20# ABC Fire Extinguisher \$25.50
- Scott Air Cylinder per refill \$5.00

(Cost of the above based on existing prices on October 2015)

There is no charge for Mutual Aid to the ambulance unless fire fighting equipment is used. The charge will then be 1/2 the normal rate.

There will be no charge if the fire call is cancelled before the trucks leave the hall, however if the trucks are enroute, there will be a charge.

~~The Town of Eau Galle agrees to pay for this service its prorated share (based on a per section served ratio) the cost of operating and maintaining all fire fighting equipment and the fire hall, now in service, and any equipment which may be purchased in the future. Any major equipment or maintenance expenditures will be done with the approval of the Town of Eau Galle. For the purpose of prorating shares the Village of Elmwood shall be a 36 section unit, the Town of Rock Elm a 36 section unit, the Town of El Paso a 17 section unit, the Town of Spring Lake a 17 section unit, the Town of Weston a 30 section unit, the Town of Eau Galle a 26 section unit, and the Town of Lucas a 2 section unit. The cost of service per section provided by the Elmwood Area Fire Department, Inc will be determined each year at the annual meeting of the corporation. Should any municipality wish to increase the number of sections served by the Elmwood Area Fire Department, Inc, the same charge per section will be made.~~

The Town of Eau Galle agrees that should the Elmwood Area Fire Department, Inc be unable to respond to any fire call because of conditions beyond their control, the Elmwood Area Fire Department, Inc shall be relieved of any and all legal liability for failure to provide service.

The Town of Eau Galle agrees that in the event of an emergency any fire fighting equipment owned by the Elmwood Area Fire Department, Inc may be used in any other area, where that emergency may occur.

The Elmwood Area Fire Department, Inc agrees that all revenue collected will be credited to a separate account in their control, and that a detailed report as to the financial condition of the Elmwood Area Fire Department, Inc be given each municipality at least once each year.
