Treasurer Valerie Baskin gave treasurer report with an ending balance of \$248,476.86. A motion by 1st Supervisor Bill Hartung to accept treasurer's report & second by 2nd Supervisor Audrey Martin. MC.

Vouchers were presented for approval. A motion by 1st Supervisor Bill Hartung to accept vouchers presented & second by 2nd Chairman Audrey Martin. MC.

Public Comments: Charlie Weber presented to Chairman Don Hartung information form USDA regarding grants for equipment for towns.

A motion was made by 1st Supervisor Bill Hartung to approve picnic/retail license for St Henry's Springfest on April 28th, 2024 and second by 2nd Supervisor Audrey Martin. MC

Chairman Don Hartung discussed ARIP program is 90/10 share. It must be engineered and then it cannot be banned on the road for 10 years. One mile of road will be well over 1 million. Dustin from Dunn Cty Hwy agreed with Chairman Don Hartung that Town of Eau Galle is not a good fit.

Chairman Don Hartung stated no bridge petitions this year for Town of Eau Galle. Dunn County Hwy will be performing inventory and inspections of 6' to 20' culverts.

Chairman Don Hartung discussed Shared Revenue (maintenance of effort) for Fire & EMS. With that shared revenue increase of \$42,973.00 we have 4 forms to complete and Public Safety will create reports to file by July 1, 2024 otherwise 15% penalty will be issued.

A motion was made by 2nd Supervisor Audrey Martin to sell old town shop and list with Prime Realty (The property will be listed at \$135,000.00) and seconded by 1st Supervisor Bill Hartung. MC
