

**2024 Town of Eau Galle  
5/13/24 Town Board Meeting Minutes**

The meeting was called to order at 6:00 p.m. by Chairman Donald Hartung on Monday, May 13<sup>th</sup>, 2024, at Town Hall, Eau Galle, WI.

Chairman Donald Hartung called for roll call; present were Chairman Donald Hartung, 1<sup>st</sup> Supervisor Bill Hartung, 2<sup>nd</sup> Supervisor Audrey Martin, Treasurer Valerie Baskin, & Clerk Martha Hartung. In attendance was Terry Wayne, Dick Fritz, Dave Wolf, & Carole Jean Baier. Chairman Donald Hartung lead us in Pledge of Allegiance.

A motion was made by 1st Supervisor Bill Hartung to accept minutes from the 4/8/24 meeting and second by 2nd Supervisor Audrey Martin. MC

Treasurer Valerie Baskin gave treasurer report with an ending balance of \$403,127.26. (.01 corrected per Treasurer V Baskin) A motion by 1st Supervisor Bill Hartung to accept treasurer's report & second by Chairman Donald Hartung. MC. Deposit was made of \$131,849.50 for sales of old town shop & salt shed from Buhlman Grandchildren Trust. We will get a refund of \$427.50 for tax Stamp recording as Town of Eau Galle is tax-exempt.

Vouchers were presented for approval. A motion by 1<sup>st</sup> Supervisor Bill Hartung to accept vouchers presented & second by 2nd Chairman Audrey Martin. MC.

Public Comments: Concerns were brought up about different roads in town. Dave Wolf made mention of concrete missing on Bridge off Cty Rd C crossing to 220<sup>th</sup>. No sweeping of streets.

Chairman Donald Hartung discussed blacktopping parking lot. It was decided to get bids at this time. We will get ad in paper next week and run for 2 weeks.

A motion was made by 1st Supervisor Bill Hartung to approve four bridge inspections with Dunn County which cost \$480.00/per bridge. and second by 2nd Supervisor Audrey Martin. MC

Chairman Donald Hartung tabled bridge sealing with Farhner until bridge inspections completed. Farhner estimate currently is \$38,703.72 for 3 bridges that need sealing which are located by Roger Baire, Tom Hartung's and Ted Weinzirls.

A motion was made by 1st Supervisor Bill Hartung to approve pulverizing with Dunn County for 130<sup>th</sup> Ave for \$4,300.12 and second by 2nd Chairman Donald Hartung. MC

A motion was made by 1st Supervisor Bill Hartung to approve 2025 budget of \$292,355.00 for Durand Rural Fire Department and second by 2nd Supervisor Audrey Martin. MC

A motion was made by 1st Supervisor Bill Hartung to approve the purchase of JD 2016 x750 690H lawn mower for \$7,499.00 and second by 2nd Supervisor Audrey Martin. MC
