## 2025 Town of Eau Galle 10/15/25 Town Board Meeting Minutes

The meeting was called to order at 6:00 p.m. by Chairman Donald Hartung on Monday, October 15th, 2025, at Town Hall, Eau Galle, WI.

Treasurer Valerie Baskin gave the treasurer a report with an ending balance of \$270,559.34. A motion by 1st Supervisor Bill Hartung to accept treasurer's report & second by Chairman Donald Hartung. MC

Vouchers were presented for approval with hold of check to Elmwood Area Fire Dept check #15705 for \$5,850.00 to check on Forster fire call and a motion by Chairman Donald Hartung to accept vouchers presented & second by 1st Supervisor Bill Hartung. MC

Chairman Donald Hartung read Resolution 2025-1 which is Resolution of Town Board Proposing to Exceed Levy Limit which is \$363,241. This will be presented to Electors to vote on November 10<sup>th</sup> 2025 meeting. We had a vote of 3 aye and 0 nay. Resolution 2025-1 passed.

Chairman Donald Hartung presented the Town Board the preliminary 2025-2026 budget.

A motion was made by 1st Supervisor Bill Hartung to Amend the 2025 budget by \$74,121 donation by Eau Galle Sanitary District to be used to pay down debt on new town hall and second by 2nd Supervisor Brian Lamm. MC

Public Comments: Treasurer Valerie Baskin let us know that there is new tax software for this year. She stated that she will not be mailing paid receipts without stamped envelope or Tax roll. Dunn Cty PASER rating is completed for our town roads. Chairman Donald Hartung stated that Cole Kangas our new patrolman is hired, and he will start on 12/1/25. Jim Moody called asking if the town has any used culverts. We do and it will be \$50.00 for used 11'x18" culvert. Clerk Martha Hartung asked to review capital outlay to carry forward due to Road project on 130<sup>th</sup> Ave. Dick Fritz brought up vehicles parked on street. Chairman Donald Hartung will talk to resident about moving vehicles parked on street before plowing starts.
