

**2025 Town of Eau Galle
11/10/25 Town Board Meeting Minutes**

The meeting was called to order at 6:39 p.m. by Chairman Donald Hartung on Monday, November 10th, 2025, at Town Hall, Eau Galle, WI.

Chairman Donald Hartung called for roll call; present were Chairman Donald Hartung, 1st Supervisor Bill Hartung, 2nd Supervisor Brian Lamm, Treasurer Valerie Baskin, & Clerk Martha Hartung. A motion was made by 1st Supervisor Bill Hartung to accept meeting minutes from 10/1/25 and 10/15/25 and second by 2nd Supervisor Brian Lamm. MC

Treasurer Valerie Baskin gave the treasurer a report with an ending balance of \$219,552.54. A motion by 1st Supervisor Bill Hartung to accept treasurer's report & second by Chairman Donald Hartung. MC

Vouchers were presented for approval and a motion by 1st Supervisor Bill Hartung to accept vouchers presented & second by 2nd Supervisor Brian Lamm. MC

Public Comments: Discussion about vehicles parked on street. Other discussion about roads and applying for grants for roads.

A motion was made by 1st Supervisor Bill Hartung to Approve contract with Dunn County Humane Society for \$1,683.45 which is \$420.86 per quarter and second by 2nd Supervisor Brian Lamm. MC

A motion was made by 2nd Supervisor Brian Lamm to approve Contract with Justin Steinmeyer Inspections from 10/1/25 to 12/31/2026 and seconded by 1st Supervisor Bill Hartung. MC

A motion was made by 1st Supervisor Bill Hartung to join Durand Fire District by Resolution 2025-4 and seconded by 2nd Supervisor Brian Lamm. MC

Appointment to the Durand Fire District was completed with Donald J Hartung as 1st Director, Brian Lamm as 2nd Director and Bill Hartung as 3rd Director.

A motion was made by Chairman Donald Hartung to approve Elmwood Fire Dept Agreement for short year for 2025 and full year for 2026 and seconded by 1st Supervisor Bill Hartung. MC
